SOLID WASTE AND BAG LIMIT: Rates effective January 2 is \$100.00. If payed after January 31st the rate will be \$150.00 or garbage pickup will be **CANCELLED!** We have a three (3) bag – 30 gallon size limit per week. Extra garbage will not be picked up without a Garbage Sticker. Additional garbage stickers for trash bags are available at the Township Municipal Services Building at \$1.50 each.

Remember – leaves, grass clippings and **animal waste** should not be included in your weekly garbage and **WILL NOT BE PICKED UP!** Garbage must be at your **curbside by 7:00 A.M.** If a Holiday falls on a Monday, Monday's pick-up will be on Wednesday; Tuesday's pick-up will remain the same. Monday Holidays in 2019 will be: , Labor Day, Memorial Day & New Year's Day

Annual Christmas Tree Collection will be January 16, 2019. Please do not wrap trees in plastic bags, No return calls for Christmas Trees!

2019 Spring Clean-Up will be April 10th and 11th. Fall Clean-Up will be October 9th, and 10th, Mar Lin, Yorktown, Deer Park, Brookshire, Woodland Acres, and Hillside will be WEDNESDAY.

Brier City, Seltzer, Norwegian Woods, Seltzer Highway, New Street, Peach Mountain, Water Street, Mamie's Avenue, Mill Creek Avenue, St. Clair Avenue, and Ann Street will be THURSDAY.

Please separate acceptable materials at curbside into scrap metal, wood, rugs, etc. **NO LARGE FURNITURE OR APPLIANCES, TIRES, BATTERIES, OR PAINT CANS!** Cleaning households is a commercial enterprise and the Township is not in this business. If you are moving into a house, do not use the clean-up for this purpose, or, when moving, do not abuse the privilege! **We no longer have an outlet for TV's, computers or computer monitors. Any resident caught bringing in refuse from outside the township and placing it for pick-up at their residence during the fall and spring cleanup will result in a \$300.00 fine for littering for each offense.**

SEWER USERS FEE: Sewer rate will be \$48.00. Sewer users are requested to keep their payments current. As a reminder, there is a \$5.00 Penalty Fee if not paid by the 15th of each month. After 90 days water will be shut off.

PLANNING AND ZONING: Building and Zoning Permits may be obtained from the Township Zoning Officer, Michael Miller, Mar Lin, who may be reached at 570-622-8638, Ext. 6. **Building and Zoning Permits MUST be acquired before any work begins.** Planning Commission meets the last Monday of each month.

COMPOST SITE: Located on Brier City Road, behind Seltzer. Clippings from shrubs, grass, and tree branches only. No large trees or household garbage allowed. The site is open 8:00 a.m. to 5:00 p.m. on Saturday; and Monday through Friday, the key to the Compost Site can be picked up at the Township Building between 8:00 a.m. and 12:00 noon. **Dumping material along roadside leading into the Compost Site is not permitted. Do not leave clippings in plastic bags or in empty plastic flower pots.**

RECYCLING: In order to keep the Solid Waste (Garbage) Fee at \$100.00 per year, we encourage all residents to recycle. The recycling bins are located at the Township yard. Hours of operation are 7:00 a.m. – 4:00 p.m., Monday through Saturday. Items which can be recycled include: paper, cardboard, magazines, plastic, glass, aluminum, and Tin cans. **Cardboard boxes must be broken down.** Styrofoam is not recyclable.
